The board reviews the three-lot map and finds it acceptable.

There are some neighbors in attendance, Jessica Hicks speaks for her and her husband. They have put in an offer to the owner they have a few questions. They have questions about buildings or homes being put up on these lots. Chairman Welshko explains to her that the issue before the board to night is whether they can legally divide the property; not about what the future use of the property may be. He explains that no roads or buildings are proposed at this time. When and if these lots are sold, and other things, like single family homes are proposed that is not something that would come before the planning board. That would go before the

Codes Officer to make sure that they comply with building code. CEO Mark Miller gives a few examples of the criteria for the concerned audience member. They are concerned about the value of their property if "manufactured homes" were to be put on that land. The audience looks at the map, it is explained that this board is an enforcement board. The process is explained further for the audience about what other codes and permits may apply.
