Supervisor Shwartz asked Ms. Wilcox about why there is a difference between the tax roll and the assessment numbers from the County? Ms. Wilcox said that she spoke with the Assessor and their program is constantly updating. The number difference is not significant. Supervisor Shwartz asked her to contact the County again to see if the numbers will change. Ms. Wilcox said that right now, the numbers on the budget are the same numbers that the County provided that they provided in their email. Ms. Wilcox will ask the County if the numbers will change again prior to the tax bills being run. Supervisor Shwartz reiterated that the purpose of the meeting was to meet post referendum, but the town will still owe the \$400,000, so there is no getting around that. We also still need to rebuild the fund balance. We just don't know how much we need to rebuild it. So the \$75,000 that is in the budget is basically causing this amount of increase. Maybe in five years, we won't have as much of a hole to build back up. And then we'll be able to drop the taxes.
