Section 1. Title: This law shall be known as "A Local Law To Authorize Purchasing Based on Best Value".

Section 2. Declaration of Intent: General Municipal Law Section 103 requires that certain purchase contracts (including contracts for services) are subject to competitive bidding. Historically it was required that such contracts be awarded to the lowest responsible bidder whose bid meets the requirements of the specifications for the project. Section 103 was amended to allow consideration of "best value" if a Town passes a local law authorizing the consideration of "best value". The intent of this local law is to allow the Town Board the option to consider "best value" as defined in New York State Finance Law Section 163. The Town Board hereby determines that it is in the best interest of the Town and its residents to have the authority to consider "best value".

Section 3. Authority: This local law is enacted pursuant to New York General Municipal Law Section 103.

Section 4. Definitions: "Best value" shall be defined as set forth in New York State Finance Law Section 163.

Section 5. Application: To the extent allowed by General Municipal Law Section 103, the Town may consider "best value". Factors that may be considered include, but are not limited to:

- (A) lowest cost of maintenance;
- (B) durability;
- (C) higher quality;
- (D) longer product life;
- (E) location.

Section 6. Severability: If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 7. Effective Date: This local law shall take effect immediately upon filing with the Secretary of State.
